Tips for Successful Submission of an Individual Educational Activity

The Approver Unit of the International Association of Forensic Nurses seeks to support Individual Educational Activity (IEA) applicants in submitting a successful program.

To streamline your approval process:

- 1. Read the application carefully it prompts you how to complete a thorough application.
- 2. Ensure you complete all required fields and check all required boxes.

Section 4: Conflict Resolution (to be completed by Nurse Planner)

For example, Nurse Planners often miss the checkbox on the Conflict of Interest (COI) form in section four. The Nurse Planner must indicate either that they have resolved any conflicts of interest or have determined that conflict resolution is inapplicable.

- Ensure that all your attachments are included.
 For example, if you list 9 presenters and 3 (non-presenter) planning committee members, you need to submit 12 COI forms. Be sure to check your math.
- 4. Ensure consistent language throughout your document. For example, if you state the title of your program on the application as "The Benefits of Team Training and Team Communication," but the planning table says "Team Training Take Five" and the marketing tool says "Team Dynamics: Learn to be a great team through communication," you will need to select one title and use it consistently on all your documents: the application, the planning table, the marketing tools, the agenda, the certificate sample, and the COIs.
- 5. Use the planning table to calculate the contact hours. The calculation is: (total number of minutes from the time column) \div 60 = contact hours. For programs lasting longer than 4 hours

(those requiring an agenda), the Nurse Peer Reviewers and the Nurse Peer Review Leader should ensure that the times on the agenda match those on the planning table. For example, if the planning table states:

and the agenda states:

9am – 10amStaying In Your Lane: How Nurse Practice ActsFictional Nurse, MSN, RN, SANE-AApply to Forensic Nursing

these two documents correlate; the content is 60 minutes' duration and

 $60 \div 60 = 1.0$ contact hour.

Ensure that your planning table always corresponds directly to your agenda. The title of the section, the time frame, and the lecturer should all match.
